Regular Business

Old Business

 Laura gave an overview of the March 5 Roundtable event. Laura, Mary McNamara (Esopus Creek) and Jason West (Wallkill River) met to discuss earlier in the year to discuss. Emily Vail (HRWA) and Amanda Lavalle (UCDOE) put together the event that was held at Cornell Cooperative Extension in Kingston. The goal is to work with ECC's/CAC's in Ulster County. RCWA member Andrew Faust presented on sustainable farming practices in the watershed.

- a. Laura will get notes from the meeting for follow-up.
- 2. The group discussed finishing the brochure. Eric will provide the group with images rather than outreaching to municipalities. The map is nearly done. Fiscal sponsorship is still an issue, and the group decided it will first assess the brochure costs once it's been created before pursuing anything else.
- 3. The RCWA needs a social media policy to help guide how it posts on facebook. Emily Vail said that the Hudson River Watershed Alliance had a communications plan created in 2018. That plan recommended that they develop a plan for social media, but doesn't actually include any resources. NEW BUSINESS

1. The RCWA created a survey to connect volunteers with tasks and to collect new ideas. Three people took the survey. The names and contacts have been kept confidential, but the responses are the following:

a. What skills do you have?

 "I am the Watershed Planning Coordinator for the Rondout Neversink Stream Program. I am responsible for designing and implementing riparian buffer plantings through the Catskill Streams Buffer Initiative program. I also am responsible for creating the educational and outreach content for my program. I have experience with GIS mapping, Trimble GPS input, Adobe Creative Suite and designing and planting riparian buffers."

- iii. "Retired EPA Water Enforcement Officer, specialized in MS4 work."
- b. What Issues Interest you on the Rondout Creek?
 - i. All stated water quality
- c. What other Rondout Creek Watershed initiatives would you be interested in working on?
 - i. "I am interested in becoming more involved in water sampling and analysis. I am also interested in participating in riparian buffer planting projects. Ultimately, I hope to bridge the gap between the Rondout Creek headwaters and tailwaters, through educational community programs and citizen science research."
- d. If you'd like, please tell us what the Rondout Creek means to you.
 - i. "Rondout Creek is a path of nature that deserves to be protected, researched, and celebrated. It is an ever-changing pathway that geographically connects my work place and my home. It is where I go to unwind on the weekend. To me, it represents an opportunity to connect with nature."
 - ii. "Home for local wildlife"
- e. Anna said that she attended the recent omelet that hosted Emily Vail of the Hudson River Watershed Alliance. The presentation pulled good photos of social distancing and would like to collect geo-references of where they were taken. She noted that the Estuary Program was moving forward with their effort to find homes for 2700 bare root plants. She was seeking people who were efficient and effective at potting and willing to follow social distancing protocol. The date to plant is tentatively May 5-8.
